# "Chelmarsh Parish Council

Parish council meeting held on Tuesday 24th July 2018 at 7.30pm in Chelmarsh Parish Hall.

#### 0. Parishioner's time:

Parishioner raised the problem of cars parked along Bakehouse Lane – Clerk had previously reported this to SC but will look into this again.

The dumped aerials have been removed.

Street light – will check to see if this has been repaired.

#### 1. Apologies for absence:

Cllr A Cadwallader (work), R Tindall (holiday). It was **RESOLVED to accept these** apologies.

#### 2. Declaration of interests:

The Localism Act 2011, Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012.

Members are reminded that they are required to leave the room during the discussion and voting on matters in which they have a disclosable pecuniary interest, whether or not the interest is entered in the register of member's interests maintained by the Monitoring Officer. None declared.

# 3. Mr John Steven – Consultant to FCFM Group.

The meeting was suspended at this point to allow the speaker to outline the proposals for The Astbury.

Mr John Steven confirmed that he was a Consultant for FCFM Group which is a privately owned Investment London Company who specialise in distressed debt.

The Astbury went into administration and the Company purchased this and hope to have pre-planning applications in to SC by the end of the month, full application in October and hopefully planning permission granted by February for work to commence quickly thereafter. Proposals:

- High quality leisure development
- Golf course to close October 2018 for possibly 18 months to resolve drainage problem etc although staff will be kept on.
- Likely to employ 120 people
- Small equestrian facilities
- Short 9 hole golf course PAR 3 type
- Full service spa with treatment rooms, mud bath etc (8-12 treatment rooms)
- Leisure pool for children, fairly shallow with flume
- 5 food and beverage outlets including healthy eating
- 2 sporting facilities 1 golf clubhouse
- Bowling green and tennis courts
- Bar facilities
- 250-350 (although possibly less than 300) Lodges for accommodation on the main plateau east side of the river, in valley where current ones were started.

- Good quality lodges are aimed to be in clusters and will not be visibly off site.
   Separate car park which will not be seen and buggies/bikes will be used on the estate.
- Talking to Severn Valley Railway re: access to Station.
- £15m 51m total investment allocated and available.

The Company realise that these proposals will have a significant impact on the local community but Mr Steven will be happy to come to meetings, monthly, quarterly as requested and work together.

#### **Questions/comments to Mr Steven included:**

- What will happen in 5 year's time if the company leave? will be sold possibly to a Pension Fund.
- Access no traffic will be allowed to sue the back road. There will be a tunnel under the road to access parts of the site.
- Highway is under severe pressure at present and extra traffic this development will generate will make the problem far worse.
- Investment is needed on these roads urgently.
- HGV's will cause enormous damage will have an obligation to make good.
- A suggestion was made that the access into the old quarry between the Astbury Lane junction and the bridge should be used as visibility is better in this location.
- Main gates into The Astbury will be used this is on a dangerous/fast road and some traffic calming needs implementing.
- Emergency services will be fully stretched.
- Will this be available for 'locals' could be sued and perhaps a discount card will be available on changeover day etc.
- Broadband in the area is very poor so perhaps with this new development this will need to be improved so hopefully the whole community will benefit.
- Bridgnorth will not cope with so many extra visitors as car parks etc are already full at weekends.
- A site visit was requested to go and have a look at the plans once available. Mr Stevens confirmed that this would not be a problem.

Chairman thanked Mr Steven who confirmed that any comments made by the PC will be considered at the pre-application stage.

# Clirs RESOLVED to write to SC Planning, Highways and Mr Stevens asking for the following to be considered:

- Roads for construction traffic and future visitors need urgent improvement. The whole road from Bridgnorth through to Highley is in an awful state and urgent major work is required.
- New access suggested at the old quarry entrance between the Astbury road and Eardington railway bridge for this development.
- Right hand turning lane into The Astbury at the bottom of Haye Brook bank this is a
  particularly fast stretch of road and Cllrs feel that some improvement should be made
  here.
- Internet access will be required at The Astbury and due to the very bad connections at present for the Chelmarsh Parish (and possibly Eardington Parish) request that this is taken into account and ensure that a better connection is provided for all residents.
- Traffic calming measures for Chelmarsh Parish.
- Councillors expressed concern regarding the scale of the development which will more than double the current population of Chelmarsh.
- Emergency medical services should be considered.

It was also RESOLVED TO WRITE TO Mr Steven asking if the PC could meet at The Astbury prior to the PC meeting on the 17<sup>th</sup> September at 6.30pm then back to the Parish Hall for 7.45pm meeting.
