This application was fully discussed and **RESOLVED to support.**

b) Reference: 24/03806/FUL (validated: 04/10/2024)

Address: Astbury Hall, Astbury, Bridgnorth, Shropshire, WV16 6AT

Proposal: Installation of a private foul pump station and a private pumped foul sewage line

connecting to the Severn Trent Water adopted drainage system.

Applicant: Mr Jamie Hammond (Astbury Hall To Upper Forge Bridge With B4555, Astbury, Bridgnorth, Shropshire, WV16 6AT)

This application was full discussed and Cllrs **RESOLVED** to **OBJECT** to this for the following reasons:

All parties involved with the proposed discharge route need to be in agreement. The design for the discharge and rate of flow must be agreed by Severn Trent Water and that the treatment plant can accommodate this rate of flow. A design factor of safety should also be factored in to take account of periods of excessive rain fall to prevent any surcharge from being discharged into Morl Brook.

Can the timescales stated be met?

There should be no discharge into the Morl brook and assurance of this will be required.

c) Any received after issue of agenda: none received.

6) Reports: (if available)

a) Shropshire Councillor's report:

Cllr Tindall will not be attending meetings through the dark nights as he has a cataract and finds it difficult to drive at night, but he is available for daytime meetings and will help, where possible and will send reports through to Clerk.

b) Police – just confirmed speed survey carried out and average speed was 33.6. Concern was expressed that motorists warn each other of the Police and that this needs to be carried out mornings/evenings.

After a long discussion regarding numerous accidents along the B4555 and on Covert Lane, Hampton Loade, Loade being very narrow, pedestrians walking along the main road between Kings Arms and School Lane, etc it was **RESOLVED** to write to **SC** and the **MP** stating that we feel that the criteria is met for a lower speed limit and request multiple monitoring for a period of 6 weeks as members of the public, residents, other road users are constantly raising complaints.

- Problems raised by Cllrs:
 - Pothole by manhole opposite Garrett's bungalow reported on Fix My Street.
 - Hedges at Hampton Loade have not all been cut. This has been raised by parishioners and reported on Fix My Street as the landowner has failed to cut all

the hedges it was **RESOLVED to ask SC to cut these and invoice the landowner.**

- Pothole, top of Covert Lane plus several more in the 'wooded area' just before the junction. Clerk will report on FMS.
- Hedge at 1 The Glebe reported to Clerk who as reported to STAR Housing and on FMS. This is blocking visibility from The Glebe and photograph received from STAR housing highlights potholes, so Clerk has reported these again!
- Stile at the bottom of the playing field needs attention. As this is a FP, Clerk was asked to write to SC and ask for this to be replaced with a kissing wicket.
- Defib checked and as this was used by the Ambulance Service the PC will not be invoiced for the replacement pads. Cllr S Garrett agreed to check these regularly.

- Clerk had brought the King Charles portrait along and would leave it in the committee room, but would notify Sue Jackman regarding this, with the hope that wall space could be made for this.
