Chelmarsh Parish Council meeting held on Tuesday 27th February 2018 at 7.30pm in Chelmarsh Parish Hall.

No parishioners present.

1. Apologies for absence:

No apologies.

2. Declaration of interests:

3. Minutes of last meeting held on 22nd January 2018:

These were circulated with the agenda and it was **RESOLVED** to accept these as a true record and the Chairman signed these accordingly.

4. Matters arising from minutes:

a) Clerk's update:

Speeding update: Clerk read out email received from Alice Croft:

Thanks for forwarding this – the speed limit reminder sign (with slow down text) is the only one that we would endorse on the public highway in Shropshire as the other ones, that shows the driver's speed, have been used before in Shropshire and do not tell the driver what speed they should be driving at, only the speed they are going, so this does not promote drivers going at the correct or appropriate speed for the posted speed limit.

I have copied Jason Hughes in to this email to comment if he has any concerns or items to note. Also it is worth noting that although the signs all have their own built in rechargeable batteries, we have found in the past that when these signs are triggered on a frequent basis, the batteries can run down quite quickly which is why we use mains power where it is available. You may well need to be recharging the batteries on a very regular basis. Just a note to be wary of but if you have the means and the manpower then this is maybe not an issue!

With regards to the email from Cllr Philip Thomas

What he has highlighted with regards to village speed limits is correct. Shropshire Council introduced a Village Speed Limit Policy in 2007 which enabled all villages without a 30mph speed limit to be reviewed to see if implementation of one would be suitable for the 3 year implementation programme.

Chelmarsh was highlighted as a village that had a 40mph speed limit so was considered for potential reduction to 30mph. I met with the Parish Council and Local Member at the time, on site, to discuss the matter and it was agreed by all that the present 40mph limit was working well with speeds

appropriate for the speed limit and that the community felt they wished to keep the limit. The village also received police support and enforcement for the 40mph limit so the limit was left as it was.

This policy has since been replaced with an" all encompassing" Road Safety Policy that gives the opportunity for Parish and Town Councils to raise items that they felt were of a community concern and or of a road safety matter and these will be prioritised and reviewed annually for funding and further investigation in a future year.

There is no reason why Chelmarsh Parish Council cannot put forward a submission this year for consideration of a reduced speed limit but it will have to go via the Road Safety Policy process – this is the only mechanism to take such a request forward at present.

We are all trying to ensure that the 40mph speed limit is adhered to and are proposing to refresh 40 carriageway roundels and other markings and the Police are carrying out speed enforcement and the Safer Roads Partnership have started the ball rolling with taking forward the Community Speed Watch programme in the village. We are also aware of the issues with the existing vehicle activated sign that I have asked to be checked to ensure that it triggers at speeds of 46mph – which is the recommended as the appropriate speed by the Department for Transport (10%+2mph).

I have looked back at my previous emails regarding speed data that was gathered last summer by the Safer Roads Partnership and this shows that the average speeds (2 directional) are 38.3mph and the 85^{ih} % ile (2 directional, speed at which 85% of the traffic are travelling at or below) is 44.6mph. the Police enforce at 10% + 2 = 46mph in a 40 limit. They are therefore confirming that speeds are in line with the speed limit below the enforcement levels and will not be taking any further action at present.

Also, just as a reminder, overtaking on double white lines is also only something that the Police an enforce.

I hope that this helps address the issues raised and confirms what course of action the Parish need to do to take this request further if required.

Councillor Tindall offered to write to Alice Croft regarding the VAS being activated at 46mph. Cllrs felt that this was incorrect as motorists being flashed at 46mph in a 40mph are speeding. It currently activates at 38mph which is better than 46mph!

It was RESOLVED to accept CIIr Tindall's offer and the PC would also write and ask for the speed limit to be reduced to 30mph under the Road Safety Policy.

Community Speedwatch reply:

Clerk gave to Clir Garrett the forms which need to be completed by anyone wishing to be trained under this scheme.

At this point Unitary Cllr Tindall gave his report:

- Disappointed that the Astbury Hall plans were note turned down but stressed the need for the PC to be represented when they are objecting to an application.
- Springvale Farm finally received planning permission.
- At SC Full Council meeting a 5.9% rise in Council Tax was approved.
- Independent Remuneration Panel looked at Councillors allowances and the Leader refused to accept the proposed increase which caused the Chairman and another on the panel to resign.
- Cllr Bebb asked if he reports the state of the Highley road. Clerk confirmed that Highley PC are regularly reporting defects and Cllr Tindall would speak to Unitary Cllr Tremellen about this.
- Cllr Thomas brought up the unsatisfactory responses re: broadband at Hampton Loade from Ben Walker. Cllr Tindall suspected that the only way forward would be to contact the MP who might be able to help. Clerk also confirmed that she had invited the Airband Team to the next

meeting but wondered if this might be best left to the Annual parish meeting as bowls use the main hall on the same night as the PC and Clerk didn't think that the small room would be big enough. This was considered a good suggestion.

1. Very visible site which Clirs feel will be detrimental to the visual impact of the village - this site will be clearly visible from the main road especially along by the Bulls Head.

2. Concern regarding additional traffic which will be joining the main road which is considered to be a road hazard especially drivers who are unfamiliar with the road and in particular as this is within close proximity to the access to Astbury Hall.

3. Clirs feel that there are enough of these developments in the parish, i.e Denn Farm and the approved application for Astbury Hall.

4. Q12 on the application form asks if the development is close to a watercourse which is answered 'no'. Clirs feel that this site is within close proximity to the reservoir and expressed concern that any water from the soakaways could enter the reservoir which is the major source of drinking water for the West Midlands.

Cllrs would also like to make a comment that local residents have encountered difficulties in obtaining planning permission for 'low cost housing' yet developments such as this have been permitted.

After discussions it was **RESOLVED to write back to the Parish Hall confirming that the use is approved but asking if they would like to make a donation towards the resurfacing of the playground as this is deteriorating and needs attention.**
