Parish Council meeting held on Tuesday 25th April 2023 at 7.30pm in Chelmarsh Parish Hall.

1) Apologies for absence: Shropshire Cllr R Tindall.

2) Declaration of Interests

These had been circulated with the agenda and were proposed, seconded, and **RESOLVED that the Chairman signed these as a true record.**

4) Matters arising from minutes:

a) Clerk's update:

- Playground repairs the account had been paid in full. Chairman had spoken to the men on site, and he confirmed that a good job has been made. The grass will grow through the matting.
- Pothole, Ingram Lane 'Fixed' email received from Fix My Street. Chairman confirmed that this had been repaired correctly.
- Cllrs Woods, Thomas, and Cole added to Online banking.
- Kings Coronation coins received. It was agreed that the Clerk puts a post on the Chelmarsh Folk Facebook page, and these can be handed out at the Annual Parish Meeting.

b) Police: Clerk confirmed emails had 'bounced back' and no reply from the generic email address.

c) Parish Hall: Cllrs Woods and Cole were unable to attend the last meeting but understand that the meeting was well attended, and the fete will be going ahead with new people involved

RESOLVED that these payments were all approved and invoices/statements initialled.

Insurance – renewal - \pm 417.56 (\pm 349.36 last year) with the option of 3 year. Clerk pointed out that an offer for a quote from Zurich had been received - agreed to obtain quote. Clerk noted that on the Clerk's Forum it appears that our present insurers are the most favourable.

b) Income since last meeting - £6.21 clothes bank, £45.80 Wayleave and £19.60 (March clothes bank).

Clerk also asked for clarification for the work to be carried out to the playing field gates/fence: It was agreed to replace both gates with same format, replace the new gate post (large gate, nearest to parish hall), replace the 3-4 fence posts in front of the green container and to check any others which may be rotten and replace. John Higgins has agreed to carry out this work. It was **RESOLVED that as the gate now has a padlock with a code (known to those who need access with pushchairs) then the gates will be replaced as altering the format would cause further problems.**

8) Parish problems:

Problems raised by Cllrs:

- ✓ Bakehouse Lane all potholes and ruts Clerk has reported this several times.
- ✓ Bakehouse Lane has the national speed limit, but this is considered too fast. Clerk will question this as there are lots of properties and streetlights on this lane.
- ✓ Hampton Loade passing points damaged.
- ✓ Gullies/potholes/drain edge damage Hall Farm
- ✓ School Lane potholes Clerk confirmed that Mr Russell had sent her photos and she had sent these via FixMyStreet.
- ✓ Astbury Falls bridge when will this be repaired as residents living the other side of the bridge from Eardington are having to go out to the top of Chelmarsh Bank. Clerk pointed out that the information states 8th March-8th June. Clerk will email Eardington PC.
- ✓ Double hedges along Ingram Lane still not cut. This was considered dangerous as 2 large vehicles cannot pass, and the school buses have to stop if they meet anything. Clerk will report again.
- ✓ All gullies in the parish need cleaning out.

Highley Health and Wellbeing Group:

- Chairman reported that the 'Meet and Greet' meeting last week was well attended with 2 GP's attending from Bridgnorth Medical Practice with everything sounding very positive.
- Funding is still being sorted.
- Service at Highley will continue where it is at present until a permanent place is sorted.
- 1 GP will be on duty at Highley, and this will be on a rota system of Dr's from Bridgnorth Medical Practice. People with long term medical needs will see the same GP.
- Admin staff to remain.
- Nurse Practitioner will be available, and bloods will be able to be taken at Highley instead of having to travel elsewhere.
- They hope to include other services such as Mental Health and Dietician etc.
- Any others none.
